

INITIATIVE MEASURE TO BE SUBMITTED DIRECTLY TO THE VOTERS

The county counsel has prepared the following title and summary of the chief purpose and points of the proposed measure.

A PROPOSED PLACER COUNTY CHARTER AMENDMENT RESTRICTING THE EXPENDITURE OF CERTAIN COUNTY REVENUES DERIVED FROM THE SALE OF HYDROELECTRIC POWER TO SPECIFIC PURPOSES. The proposed amendment to the Placer County Charter would limit the discretion of the County over the expenditure of revenue it receives from the sale of hydroelectric power produced by any public agency and would instead direct that such revenue, if it is received, be used only for the benefit and capital needs of water-related agencies and districts in the county and including the County itself, but it does not specifically address incorporated cities of Placer County. The proposed Charter Amendment defines the benefits and capital needs of water-related agencies and districts as fire suppression, water infrastructure, water quality, treatment and conveyance, including waste water and septic and power infrastructure projects. The proposal would take effect on March 1, 2013 and would apply thereafter. If the Board of Supervisors proposes to use the revenue for any other purpose, the approval of a majority of the voters in the County would be required.

REQUEST FOR BOARD OF SUPERVISOR'S ADOPTION OR VOTE OF THE PEOPLE. WE, THE UNDERSIGNED, REGISTERED QUALIFIED VOTERS OF THE COUNTY OF PLACER, HEREBY PRESENT THIS INITIATIVE PETITION AND REQUEST THAT IT BE ADOPTED BY THE BOARD OF SUPERVISORS AS PROVIDED BY LAW OR SUBMITTED TO A VOTE OF THE PEOPLE. IF THE BOARD OF SUPERVISORS DOES NOT ADOPT THIS MEASURE, WITHOUT AMENDMENT, AS SPECIFIED BY LAW, IT IS REQUESTED THAT THIS MEASURE BE SUBMITTED TO THE BALLOT AT THE NOVEMBER 2010 GENERAL ELECTION. IF FOR ANY REASON THIS MEASURE IS UNABLE TO BE PLACED ON THE NOVEMBER 2010 BALLOT, AND IF THE REQUIREMENTS FOR A SPECIAL ELECTION ARE MET, IT IS HEREBY REQUESTED THAT A SPECIAL ELECTION BE CALLED AFTER NOVEMBER 2010 AS PROVIDED BY LAW. IF THIS MEASURE QUALIFIES ONLY FOR A GENERAL ELECTION, AND IS FOR ANY REASON UNABLE TO BE PLACED ON THE NOVEMBER 2010 GENERAL ELECTION BALLOT, A GENERAL ELECTION IS REQUESTED AT THE NEXT AVAILABLE TIME.

THE MEASURE: The revenues from any contract for sale of water generated electric power produced by a public agency in which the County has an interest shall only be used for the benefit and capital needs of water-related agencies and districts in the County and including the County, such as fire suppression, water infrastructure, water quality, treatment and conveyance including waste water and septic, and power infrastructure projects for the benefit of the citizens of Placer County after February 2013. Should any board or political agency propose a change of the use of such revenues for any other purpose the issue shall be presented to the board of supervisors for review, and if approved, the proposal shall be placed before the voters for approval or rejection at a regular County election.
